

AN INFORMATION CLAUSE CONCERNING PROCESSING OF PERSONAL DATA - ENROLMENT FOR DOCTORAL STUDIES

In accordance with REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, GDPR) we would like to inform you that:

1. The administrator of personal data collected during the recruitment process for doctoral studies is the Institute of Human Genetics of the Polish Academy of Sciences, 32 Strzeszyńska St. , 60-479 Poznań, hereinafter referred to as the 'Administrator'.

3. Personal data provided to the Administrator by the participants of the recruitment process will be processed in accordance with the provisions of the GDPR in order to conduct the enrolment process for studies. Personal data provided by the recruitment participant will be processed on the basis of Article 6(1)(a), (b), (c) and (e) of the GDPR , in particular in connection with the Act of 20 July 2018, The Law on Higher Education and Science and its implementing acts.
4. We inform you that the provision of personal data by you is voluntary, but to the extent required by applicable laws, mandatory and necessary for the purposes indicated in point. 3.
5. In the case of persons who have not been accepted for studies, the data will be kept for the duration of the recruitment process and, moreover, for the period of time provided for in the applicable legal regulations for the occurrence/ defence against possible claims/appeals, and moreover, for the period required by the law and internal regulations of the unit for archival purposes.
6. Personal data may be transferred to other recipients, e. g. on the basis of personal data processing entrustment agreements concluded with them, on the basis of Article 28 of the GDPR. For more detailed information, please contact the Administrator.
7. Data will not be transferred to a third country.
8. Please be advised that you have:
 - a. the right to access and receive a copy of their data
 - b. the right to rectify (correct) your personal data;
 - c. the right to limit the processing of personal data;
 - d. the right to erasure of personal data; provided that the exercise of these rights is in accordance with the applicable regulations, in particular with the GDPR;
 - e. the right to lodge a complaint to the President of the OPP (to the address of the Office for the Protection of Personal Data, Stawki st. 2, 00 - 193 Warsaw).
 - f. the right to withdraw consent

To the extent that your data is processed on the basis of your consent, you have the right to withdraw your consent to the processing of your data at any time. Withdrawal of consent shall not affect the lawfulness of the processing which was carried out on the basis of your consent prior to its withdrawal. You can withdraw your consent in the same form in which it was given.

9. Your personal data are not subject to automated decision making, including profiling.
